#### OFFICE MEMORANDUM

Subject: End-to-end Digitization of Major DBT schemes and their on-boarding on UMANG mobile platform on the occasion of the 75<sup>th</sup> Anniversary of India's Independence - regarding

The Government has set the target of end-to-end digitization of **major DBT schemes** and their availability on UMANG mobile platform as apps in time to coincide with the 75<sup>th</sup> Anniversary of India's Independence i.e. 15<sup>th</sup> August, 2022. In this connection, attention is also invited to the Office OM No. D-13016/02/2020-DBT dated 6<sup>th</sup> March, 2020 (copy enclosed).

- 2. Ministries / Departments may either achieve digitization using their own platform /portal or through ServicePlus platform developed by NIC. ServicePlus is a configurable solution offering a host of services and the DBT Mission, Cabinet Secretariat will continue to provide guidance on ServicePlus configuration and integration with UMANG. Ministries/ Departments may seek exemption of schemes from this process by referring to DBT Mission with full justification e.g. schemes with few beneficiaries/small outlay/approaching closure etc.
- 3. As on date, out of 319 DBT schemes, 153 DBT schemes have are end-to-end digitized and 71 schemes are at various stages of digitization. Further, 121 schemes are available on UMANG and 46 schemes are under process. The detailed status of DBT schemes of your Ministry / Department is placed at Annexure I.
- 4. In order to achieve the targets in a time-bound manner and to ensure better monitoring, action plans and timelines may be kindly prepared and submitted for all pending schemes as per enclosed questionnaire at **Annexure II** by email (is.dbt@nic.in) at the earliest. The questionnaire will also be made available in the respective Ministry/ Department login on DBT Bharat portal (www.dbtbharat.gov.in) to enable real time feedback.
